

ST. JOHNS COUNTY ROAD CONSTRUCTION
AND TRAFFIC INTERRUPTIONS

St. Johns County announced today that the following roads will be under construction
JANUARY 30, 2012 – FEBRUARY 5, 2012

NORTHEAST - (32082, 32095)

- Nocatee Parkway: general roadway construction; periodic lane closures and/or restrictions
- Canal Boulevard – periodic lane closures for installation of storm drainage structures and improvements
- Palm Valley Road from Palm Valley Bridge to roundabout - setting concrete poles and directional bore power lines, hanging cables
- San Juan – brush cutting with periodic lane closures
- South Wilderness Trail – periodic lane closures for installation of storm drainage structures and improvements
- 4889 Palm Valley Road - periodic lane closures, utilities construction
- Las Calinas - periodic lane closures, utilities construction
- 334 - 523 Ponte Vedra Blvd - periodic lane closures, utilities construction at various locations
- Shannon Road – road improvements
- Palm Valley Road from Mickler Road to Sawbill Palm Drive – overhead electric upgrade

- 64 Jackson Avenue - utility Construction
- Corona Road – periodic lane closures for outfall ditch cleaning: Monday, January 30th – Thursday, February 2nd
- Palm Valley Road from the roundabout at Mickler Road to the Palm Valley Bridge – periodic lane closures for mowtrimming activities: Monday, January 30th – Thursday, February 2nd
- Corona Road – utility construction
- 69 Ponte Vedra Boulevard – utility construction
- 1105 Ponte Vedra Boulevard – utility construction

NORTHWEST – (32259, 32092)

- CR 210 at St. Johns Forest - right lane closure and utility work
- US 1 at Race Track Road – periodic lane closures, utilities & road construction
- CR 210 from Russell Sampson Road to Sandy Creek – periodic lane closures, pavement replacement, and underground utility installation

- N. Bartram Trail – repairing inlet box with periodic temporary lane closures
- CR 13N near CR 208 - box culvert extensions with possible lane closures
- CR 208 and Pacetti Road – asphalt work & periodic lane closures
- Bishops Estates – asphalt work & periodic lane closures

CENTRAL – (32084)

- West Positano Avenue – underground utility installation
- SR 207 near Epic Theatre – turn lane construction
- Ravenswood Drive – periodic road closures and detours for drainage improvements
- West Augustine – periodic road closures and detours in the area surrounded by King Street to the North; 15th Street to the South; Duval Street on the East and St. Johns Street on the West due to utility and roadway improvements (through June 2012)
- Covino Ave - periodic lane and road closures, utilities construction
- Masters Drive from Avery Street to Josiah Street – drainage improvements
- US1 @ SR 312 – intersection improvements with periodic nighttime lane closures
- W. King Street - Palmer to Evergreen West to Rodriguez Street -- underground utility work and possible nighttime work
- Ravenswood from N. Whitney Street to Spring Street - street closing and detour for water line placement
- Kacie Lane – periodic lane closures for culvert installation: Monday, January 30th – Thursday, February 2nd
- N. St. Johns Street – periodic lane closures for culvert installation: Monday, January 30th – Thursday, February 2nd

SOUTHEAST – (32086, 32080)

- Old Moultrie south of SR 312 - asphalt work & periodic lane closures
- Ocean Trace from A1A to ocean – force main installation
- Deltona Blvd. in the vicinity of Mariana Place – periodic lane closures – ditch/swale maintenance: Monday, January 30th – Thursday, February 2nd
- St. Augustine South Dr. – periodic lane closures – sidewalk repairs: Monday, January 30th – Thursday, February 2nd
- Shores Blvd. & Aleida Drive – periodic lane closures for asphalt patch: Monday, January 30th – Thursday, February 2nd
- Viscaya Boulevard from Deltona Boulevard to Shores Boulevard – periodic lane closures for ditch/swale maintenance: Monday, January 30th – Thursday, February 2nd
- Valnera Court – periodic lane closures for ditch/swale maintenance: Monday, January 30th – Thursday, February 2nd
- Altara Drive – periodic lane closures for ditch/swale maintenance: Monday, January 30th – Thursday, February 2nd
- Aurora Avenue – periodic lane closures for ditch/swale maintenance: Monday, January 30th – Thursday, February 2nd
- Diosa Court – periodic lane closures for ditch/swale maintenance: Monday, January 30th – Thursday, February 2nd
- Atlantic View & Redick/Pelican – underground utilities start January 20 for approximately three weeks

SOUTHWEST – (32033, 32145)

- CR 13A from Molasses Junction to CR 305 – milling and resurfacing with lane closures
- George Miller Road from SR 13 to CR 13 - setting poles and overhead rewiring
- CR 13 from George Miller Road to Flagler Estates – pole work and overhead cable
- Yelvington Road – periodic lane closures for shoulder work: Monday, January 30th – Thursday, February 2nd

Construction signs, barricades and barriers will be used as necessary to direct motorists through and around work areas. Motorists should use caution and there may be delays. Citizens are encouraged to use alternate routes to avoid construction areas.
